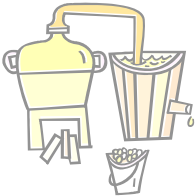
After the pain is gain! We'll meet at **BJ's Pizza** at North County Fair after the hike (7:00ish).

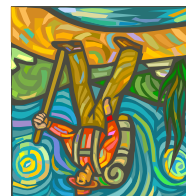
